8.	The school is required to follow rule No.2.4.7 and 2.4.8 of Affiliation Bye Laws regarding Books and Quality of Education.
9.	The number of sections in the school are restricted to 20 as per number of class rooms reported by the IC and shall not be increased without specific approval of the Board. For increase in number of sections, the School shall apply online to the Board as per rule 15.7 of affiliation bye laws.
10.	The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.
11.	The school must strive to promote conservation of environment on their campus through rain water harvesting, segregation of waste at source, recycling of organic waste, proper disposal of waste including electronic waste, use of energy saving and energy efficient electrical equipment, greening of campus, use of solar energy, education and awareness amongst children on environment conservation and cleanliness etc.
12.	The school shall submit their information through Online Affiliated School Information System (OASIS) as per details given in circular no. affiliation-06/2018 dated 24.04.2018. Link for OASIS is available on Board's website: www.cbse.nic.in.
13.	The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
14.	Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
15.	Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
16.	The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.
17.	Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and circulars/guidelines/notification issued by the Board from time to time. Any laxity in following rules/instructions of the Board will lead to action against school as per Chapter 12 of Affiliation Bye-laws-2018.
18.	Conditions, if any, to be submitted within 1 year. 1 The school has submitted copy of expired Recognition Certificate issued by "Director of Education, Govt. of Arunachal Pradesh, Shillong" dated 05.06.1976. Therefore, The School is required to submit renewal copy of Recognition Certificate as per the Section 18 of Right to Education Act, 2009 from the concerned State Government. 2 The school has not submitted copy of society registration/trust deed. Therefore, School is required to submit copy of Registration certificate for Society/Trust running the school or copy of Trust deed. 3 The school has submitted copy of Boundary Description instead of land certificate. Whereas, the school is required to submit the copy of Compact Land Certificate of Land (which includes area of land and certified that the school (name of the school with complete address should mention in the compact land certificate) & playground situated on same single plot) duly certified by Competent Authority i.e. Sub Registrar/ Tehsildar/ District Magistrate etc. to the board as per the boards' norms.

- 4 The school has not submitted land documents like lease deed/sale deed. Whereas, school is required to submit complete copy of regd. sale deed/regd. lease deed (for 30 yrs atleast) in favour of School/Society name for claimed land area.
- 5 The school has submitted copy of expired or validity not mentioned in building safety certificate. Hence, school is required to submit renewed copies of **Building Safety Certificate** issued by the competent Govt. Authorities.
- 6 The school is required to **re-constitute SMC as per Affiliation Bye-Laws**, by including 02 representative of Parent of students are studying in school, 02 teachers from same school and 02 teacher from any other school or college (of whom one shall be woman). School Principal as Member Secretary, at least 50% member in SMC should be woman and 2 CBSE representatives not below the rank of Principal of Sr. Secondary School affiliated with the Board whose nomination should be recommended from the Board and also ensure that No member relative to each other. A fresh list of SMC should be submitted along-with an affidavit dully attested by the First Class Magistrate to the effect that no member is related to each other in School Managing Committee.
- 7 The school is required to submit salary certificate issued by District Education Officer to the effect that the school is paying salaries and other Allowances. DA, HRA, PF etc. to its staff as per the state/central govt. norms.
- 8 School is required to furnish Banker Certificate to the effect that the salaries to the staff are being paid through electronic mode (ECS) / single cheque.
